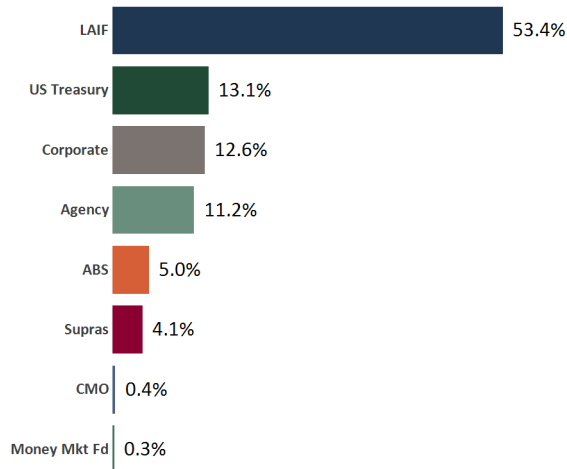

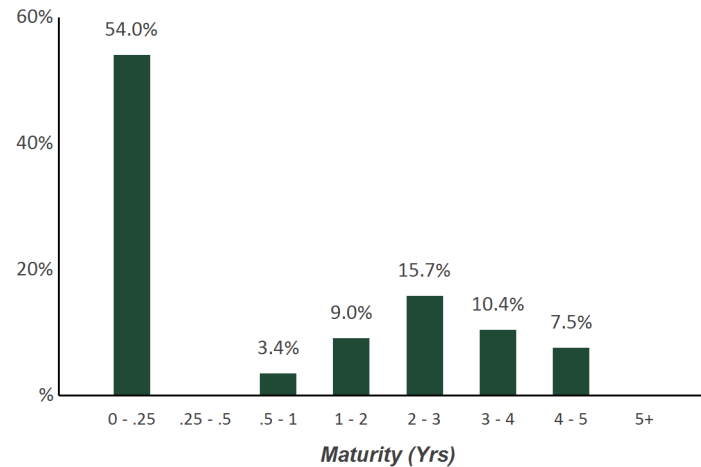

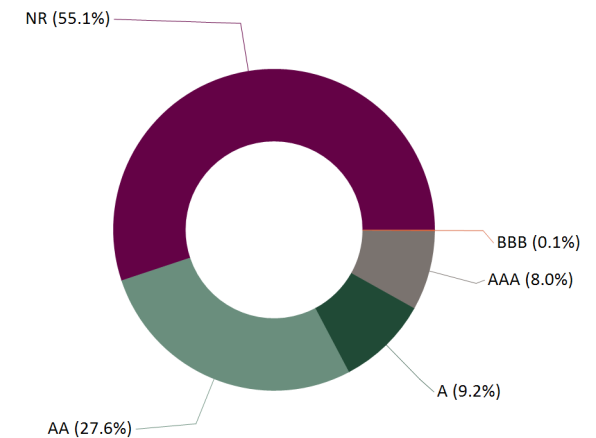
SECTOR ALLOCATION
