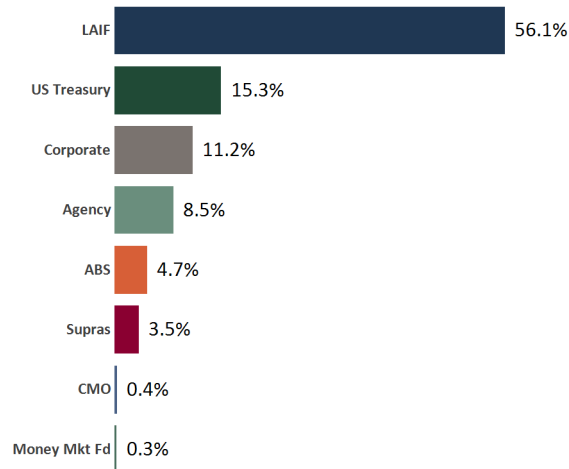

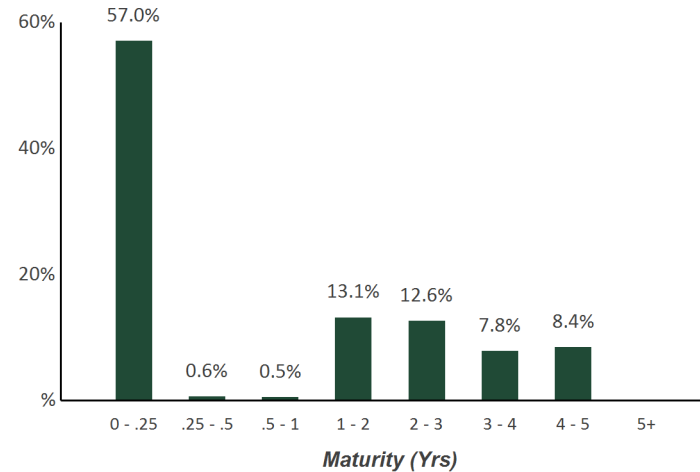

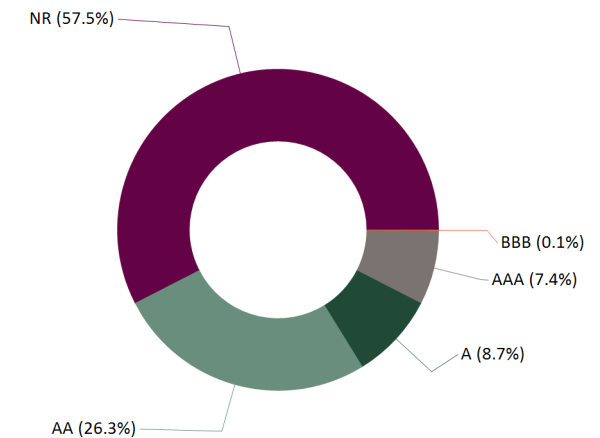
SECTOR ALLOCATION
