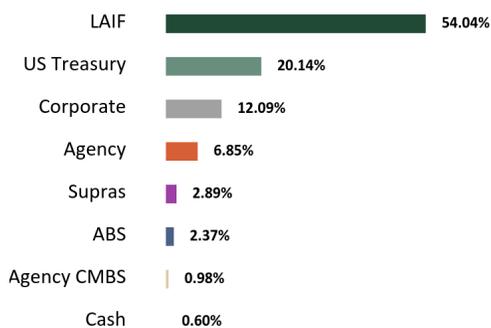

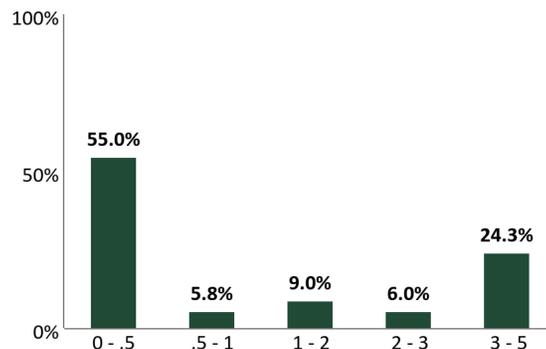

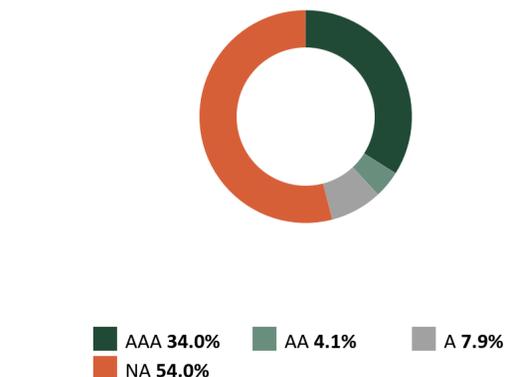
Sector Allocation
