Development of an 18.09-acre parcel into a new

residential development. The previous submittal was for a 3.29-acre parcel with a 304 unit, 5-story apartment building, a 0.73-acre parcel with an 83 unit, 5-story affordable senior apartment building, and a 14.07-acre parcel for 183 3-story townhomes and 36 2-story triplexes. Status: Project approved by Planning Commission on 6/25/25 and the Affordable Housing Agreement was approved by the City Council on 10/23/25. The Mass Grading Permit was issued on 12/23/25 and grading of the property should occur soon.

8550 Warner Avenue Project (Parkside FV)

Notice is hereby given that the City of Fountain Valley, as lead agency under California Environmental Quality Act (CEQA), has prepared a Mitigated Negative Declaration (MND) and supporting Initial Study for the 8550 Warner Avenue Project (Parkside FV).

The 2.119-acre project site is located at 8550 Warner Avenue, Fountain Valley, California (Assessor’s Parcel Number 167-361-17). The site is situated on the south side of Warner Avenue approximately 500 feet east of Newland Street. The project involves the construction of a three (3)-story, 72-unit apartment complex with 10 units set aside for very-low income households, and a one (1)-story amenity building.

The MND is available for a 30-day public review period beginning January 14, 2026, and ending February 13, 2026. The MND can be found on the Project’s webpage [HERE](#). Successful Grant Funding Secured by Engineering Staff

Congratulations to our engineering staff for successfully securing an additional \$2,039,000 in funds, after two (2) years of negotiations with OCTA. These additional funds will cover OCTA's fair share of:

- Road pavement Impacts resulting from the I-405 Improvement Project, and
- Costs associated with the Mt. Baldy Waterline Replacement Project

As part of this agreement, the city has agreed to accept the operation and maintenance responsibilities for City facilities and to accept the Freeway Maintenance Agreement (FMA) upon OCTA's completion of all project punch-list items by December 31, 2025.

The Engineering Team also received \$2.64 million in federal grant funding. On December 4, 2025, the Southern California Association of Governments (SCAG) Regional Council approved the FFY 2026-27 and FFY 2027-28 SCAG STBG/CMAQ Funding Grant Awards. This action includes a funding grant allocation award approval in the amount of \$2.64M to the City of Fountain Valley for the Rehabilitation and Resurfacing of Talbert Avenue from the Eastern City Limit to Ward Street.

Kudos to Kyle Knoke, Kyle Hilton and Ryan Damon on a job well done! It is their dedicated, steadfast effort in identifying, pursuing, and applying for this grant opportunity that helped the city secure this much-needed grant funding.
